Provided, that in case of pre-primary classes also, this norm shall be followed.

- For the children referred to in paragraph 3, the school shall be reimbursed as a per sub-section 2 of section 12 of the Act. To receive such reimbursement, the school shall provide a separate bank account.
- The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any Screening Procedure.
- The school shall not deny admission:
 - a) To any child for lack of age proof; or
 - b) If such admission is sought subsequent to the extended period prescribed period prescribed for admission; or
 - c) On the ground of religion, caste or race, place of birth or any of these reasons.
- The school shall ensure that: -
 - a) no child admitted, shall be held back in any class or expelled from school till the completion of elementary Education in a school;
 - b) no child shall be subjected to physical punishment or mental harassment;
 - c) no child is required to pass any board examination till the completion of elementary education;
 - every child completing elementary education shall be awarded a certificate as laid down under rule 21;
 - e) inclusion of students with disabilities/ special needs as per the provision of the Act;
 - f) the teachers are recruited with minimum qualifications, as laid under sub-section (1) of section 23; provided that the existing teachers who, at the time of commencement of the Act, do not posses the minimum qualifications, shall acquire such qualifications with in a period of 5 years from the date of commencement of the Act. (Which has been extended up to 31.03.2019 as per amendment in RTE Act 2009.)
